Clear Bag Policy

In order to maintain a safe and secure environment at the Buffalo County Fairgrounds, we have implemented a new bag policy that limits the size and type of bags that may be brought into our venue. Guests will be able to carry ONE of the following bags into the venue:

- One bag that is clear plastic, vinyl, or PVC and does not exceed 12" x 12" x 6".
- One gallon clear plastic freezer bag (Ziplock bag or similar).
- One small clutch purse or wallet 4.5"x6.5" (about the size of your hand) or smaller, without a handle or straps. This can be taken into the venue inside one of the clear plastic bags



Small clutch purses and wallets
4.5" x 6.5" or smaller



Does not exceed 12" x 12" x 6"

Clear Plastic Freezer Bag

All the the items listed below are prohibited; purse, backpack, clear backpack, tinted plastic bag, binocular case, empty plastic bottle, printed pattern plastic bag, oversized tote bag, mesh bag, diaper bag, fanny pack, umbrellas, and professional cameras.
